



#### DIRECTIONS FOR USE:

**USE IN LANDSCAPED AREAS:** For use in landscaped areas, around homes, or anywhere pest activity has been detected. Generously sprinkle Repellent onto the ground at any time. For best results, do not to apply the product prior to a heavy rain. Use 2 to 4 cups of product to treat an area of 100 square foot (10 foot x 10 foot). Re-treat as needed. DO NOT allow granules to collect inside water or feed containers.

Use only as directed. Not for indoor use. This product is not designed to contact food products or food crops. Daily application may be required depending on temperature, time of year and insect activity. Only for use in areas where children cannot come into contact with or ingest the granules.
